**RESOLUTION OF THE SOUTHEAST MONMOUTH MUNICIPAL UTILITIES  
AUTHORITY AUTHORIZING CAPITAL IMPROVEMENT PURCHASES AND  
ASSOCIATED LABOR FOR IMPROVEMENTS IN AN AMOUNT NOT TO EXCEED  
\$170,000.00 AND AWARDING A CONTRACT TO IRON HILLS CONSTRUCTION**

**WHEREAS**, the Southeast Monmouth Municipal Utilities Authority (hereinafter referred to as the “Authority”) serves the Township of Wall, the Borough of Brielle, the Borough of Sea Girt, the Borough of Spring Lake and the Borough of Spring Lake Heights and is comprised of member municipalities which receive treated water from the Authority; and

**WHEREAS**, within the operating budget of the Southeast Monmouth Municipal Utilities Authority funds have been reserved for Capital Improvement Purchases within the Capital Improvement Fund for the Water Treatment Plant located on Hospital Road in Wall, NJ; and

**WHEREAS**, the New Jersey Water Supply Authority’s operations and maintenance staff recently identified the need for replacement the raw water control valve at the Water Treatment Plant. The scope of work includes the purchase of a twenty-four (24) inch butterfly valve and battery UPS and includes SCADA programming; and

**WHEREAS**, bids were received in June 14, 2014 and Iron Hills Construction of Wayne, New Jersey submitted the low bid in the amount of **\$160,305.00**.

**WHEREAS**, the total cost for the Capital Improvements is expected not to exceed the amount of \$170,000.00; and

**NOW, THEREFORE, BE IT RESOLVED** by the Southeast Monmouth Municipal Utilities Authority that it hereby authorizes use of the Capital Improvement Fund by the New Jersey Water Supply Authority to proceed with the Capital Improvement Purchases and associated labor for the purchase of the Raw Water Valve Improvements at the Manasquan Water Treatment Plant for an amount not to exceed \$170,000.00 and to award the contract to Iron Hills Construction for an amount of \$160,305.00.
