RESOLUTION OF THE SOUTHEAST MONMOUTH MUNICIPAL UTILITIES AUTHORITY AUTHORIZING CAPITAL IMPROVEMENT PURCHASES AND ASSOCIATED LABOR FOR IMPROVEMENTS IN AN AMOUNT NOT TO EXCEED \$52,000.00 AND AWARDING A CONTRACTS TO NATIONAL FENCE SYSTEMS AND ALTERNATE ENERGY & ELECTRIC

WHEREAS, the Southeast Monmouth Municipal Utilities Authority (hereinafter referred to as the "Authority") serves the Township of Wall, the Borough of Brielle, the Borough of Sea Girt, the Borough of Spring Lake and the Borough of Spring Lake Heights and is comprised of member municipalities which receive treated water from the Authority; and

WHEREAS, within the operating budget of the Southeast Monmouth Municipal Utilities Authority funds have been reserved for Capital Improvement Purchases within the Capital Improvement Fund for the Water Treatment Plant located on Hospital Road in Wall, NJ; and

WHEREAS, the New Jersey Water Supply Authority's operations and maintenance staff recently identified the need for replacement of 140 foot chain link fence and installation of an additional 750 linear feet of vinyl coated galvanized chain link fence. Additionally, an aluminum framed electric gate with censor controls will be installed at the Water Treatment Plant; and

WHEREAS, bids were received in June 19, 2014 and National Fence Systems for installation of the fencing in the amount of \$43,170.00 and Alternate Energy & Electric for electrical work submitted the low bid in the amount of \$4,800.00.

WHEREAS, the total cost for the Capital Improvements is expected not to exceed the amount of \$52,000.00; and

NOW, THEREFORE, BE IT RESOLVED by the Southeast Monmouth Municipal Utilities Authority that it hereby authorizes use of the Capital Improvement Fund by the New Jersey Water Supply Authority to proceed with the Capital Improvement Purchases and associated labor for the replacement of 140 foot chain link fence and installation of an additional 750 linear feet of vinyl coated galvanized chain link fence in addition to an aluminum framed electric gate with censor controls at the Manasquan Water Treatment Plant for an amount not to exceed \$52,000.00 and to award the contract to National Fence Systems for an amount of \$43,170.00 and Alternate Energy & Electric for an amount of \$4,800.00.
