## SOUTHEAST MONMOUTH MUNICIPAL UTILITIES AUTHORITY RESOLUTION NO. 2014-16

RESOLUTION OF THE SOUTHEAST MONMOUTH MUNICIPAL UTILITIES AUTHORITY AUTHORIZING CAPITAL IMPROVEMENT PURCHASES AND ASSOCIATED LABOR FOR IMPROVEMENTS IN AN AMOUNT NOT TO EXCEED \$67,058.00 AND AWARDING A CONTRACT TO MIDCOAST MECHANICAL INC.

WHEREAS, the Southeast Monmouth Municipal Utilities Authority (hereinafter referred to as the "Authority") serves the Township of Wall, the Borough of Brielle, the Borough of Sea Girt, the Borough of Spring Lake and the Borough of Spring Lake Heights and is comprised of member municipalities which receive treated water from the Authority; and

WHEREAS, within the operating budget of the Southeast Monmouth Municipal Utilities Authority funds have been reserved for Capital Improvement Purchases within the Capital Improvement Fund for the Water Treatment Plant located on Hospital Road in Wall, NJ; and

WHEREAS, the New Jersey Water Supply Authority's operations and maintenance staff recently identified the need for replacement of the Air Handler heating unit servicing a large pump room and the chemical feed areas. Additionally, approximately 20 feet of rusted galvanized duct will be replaced at the Water Treatment Plant. The scope of work includes delivery and installation of a Trane air handler unit as well as replacement of rusted duct work; and

WHEREAS, bids were received in June 14, 2014 and Midcoast Mechanical Inc., New Jersey submitted the low bid in the amount of \$67,085.00; and

**WHEREAS**, the total cost for the Capital Improvements is expected not to exceed the amount of \$67,085.00; and

NOW, THEREFORE, BE IT RESOLVED by the Southeast Monmouth Municipal Utilities Authority that it hereby authorizes use of the Capital Improvement Fund by the New Jersey Water Supply Authority to proceed with the Capital Improvement Purchases and associated labor for the purchase and installation of a Traine Air Handler heating unit and galvanized duct at the Manasquan Water Treatment Plant for an amount not to exceed \$67,085.00 and to award the contract to Midcoast Mechanical Inc. for an amount of \$67,085.00.
