There would be \$236,771.00 to offset CY2016 budget needs. Expenses have remained stable for the past 3-4 years. Paul McKeon gave an update on the water plant stating the plant was running smoothly and would be shut down for the next two weeks (two separate shutdowns as it would go back online for the weekend) for replacement of the raw water valve.

There being no old business, no further new business and no public comment, Chairman Dempsey called for a motion to adjourn.
