## SOUTHEAST MONMOUTH MUNICIPAL UTILITIES AUTHORITY MEETING MINUTES <u>June 11, 2015</u> 9:30 AM

The Southeast Monmouth Municipal Utilities Authority members met in the Wall Township Municipal Building on June 11, 2015. In old business, Paul McKeon said the plant was running well. The possible \$20,000 expense for refurbishing the filtered water pumps would likely not exceed \$6,000.00. The flooding situation that occurred in late May had been handled and new procedures are in place to prevent a reoccurrence.

Mark Kitrick will meet with the members this month regarding the purchase of chemicals and will keep Steven Mayer informed as he had been contacted by Hamilton Township.

Tom Nolan, considered indispensable especially in the formation of the SMMUA, was thanked by the members for all his hard work.

There being no further old business, no new business and no public comment, Chairman Dempsey called for a motion to adjourn.
