RESOLUTION OF THE SOUTHEAST MONMOUTH MUNICIPAL UTILITIES AUTHORITY AUTHORIZING A CONTRACT WITH MIRACLE CHEMICAL COMPANY FOR SODIUM HYPOCHLORITE

WHEREAS, the Southeast Monmouth Municipal Utilities Authority seeks to award the bid to Miracle Chemical Company and authorizes Counsel for the Authority to prepare a contract to be executed by the parties; and

WHEREAS, the bid process and the awarding of the contract is pursuant to the cooperative purchasing guidelines of the Southeast Monmouth Municipal Utilities Authority; and

WHEREAS, the Financial officer of the Authority has determined that sufficient funds are available for the contract; and

WHEREAS, Miracle Chemical Company has completed and submitted a Business Entity Disclosure Statement which certifies and that Miracle Chemical Company has not made any reportable contributions to a political candidate committee which would be prohibited by law.

NOW, THEREFORE, BE IT RESOLVED by the Southeast Monmouth Municipal Utilities Authority as follows:

- The Authority Chairman is hereby authorized to execute a contract with Miracle Chemical Company.
- A copy of this resolution together with the Business Disclosure Entity Certification submitted by Miracle Chemical Company. shall be placed on file in the Authority Offices.
- 3. The Authority Secretary shall arrange for publication of Notice of the foregoing action of the Authority in the authority's official newspaper.
