RESOLUTION OF THE SOUTHEAST MONMOUTH MUNICIPAL UTILITIES AUTHORITY AUTHORIZING A RENEWAL & REPLACEMENT TRANSFER OF FUNDS INTO THE 8101 OPERATING FUND FOR AN AMOUNT NOT TO EXCEED \$6,400.00

WHEREAS, the Southeast Monmouth Municipal Utilities Authority (hereinafter referred to as the "Authority") serves the Township of Wall, the Borough of Brielle, the Borough of Sea Girt, the Borough of Spring Lake and the Borough of Spring Lake Heights and is comprised of member municipalities which receive treated water from the Authority; and

WHEREAS, within the operating budget of the Southeast Monmouth Municipal Utilities Authority funds have been reserved within the Renewal and Replacement Reserve Account for the renewal and replacement of equipment for the Water Treatment Plant located on Hospital Road in Wall, NJ; and

WHEREAS, the New Jersey Water Supply Authority's operations and maintenance staff recently identified the need for a transfer of funds from the renewal and replacement reserve into the 8101 operating fund for a ductile iron pipe since the existing pipe developed a leak due to corrosion from two (2) taps in the pipe that are used for chemical application to the finished water; and

WHEREAS, the total cost, inclusive of labor, for the replacement of the existing pipe and replace it with a new pipe with two (2) new taps, flanges and a new concrete support at the Manasquan Water Treatment Plant is in the amount of \$6,400.00; and

WHEREAS, Mark Woszczak Mechanical Contractors submitted the low bid to provide the materials and perform the installation; and

NOW, THEREFORE, BE IT RESOLVED by the Southeast Monmouth Municipal Utilities Authority that it hereby authorizes the New Jersey Water Supply Authority to proceed with the transfer of funds from the renewal and replacement reserve into the 8201 operating fund for the removal of the existing pipe of a 65" section of an 18" diameter ductile iron pipe and replace it with a new pipe with two (2) new taps, flanges and a new concrete support with the work to be performed by Mark Woszczak Mechanical Contractors at the Manasquan Water Treatment Plant for an amount not to exceed \$6,400.00 to cover the cost of this expense.
