## SOUTHEAST MONMOUTH MUNICIPAL UTILITIES AUTHORITY RESOLUTION NO. 2015-20

RESOLUTION OF THE SOUTHEAST MONMOUTH MUNICIPAL UTILITIES AUTHORITY AUTHORIZING CAPITAL IMPROVEMENT PURCHASES AND ASSOCIATED LABOR FOR IMPROVEMENTS IN AN AMOUNT NOT TO EXCEED \$24,630.00 AND AWARDING CONTRACT TO MUNICIPAL MAINTENANCE COMPANY

WHEREAS, the Southeast Monmouth Municipal Utilities Authority (hereinafter referred to as the "Authority") serves the Township of Wall, the Borough of Brielle, the Borough of Sea Girt, the Borough of Spring Lake and the Borough of Spring Lake Heights and is comprised of member municipalities which receive treated water from the Authority; and

WHEREAS, within the operating budget of the Southeast Monmouth Municipal Utilities Authority funds have been reserved for Capital Improvement Purchases within the Capital Improvement Fund for the Water Treatment Plant located on Hospital Road in Wall, NJ; and

WHEREAS, the New Jersey Water Supply Authority's operations and maintenance staff recently identified the need for security improvements at the Water Treatment Plant. The scope of work consists the complete replacement of a one (1) stage vertical turbine pump and the refurbishing of 24 feet of 14 inch diameter pump head and column pipe (other items necessary for the replacement of the grating shall be performed by Authority employees); and

WHEREAS, bids were received on September 17, 2015 and Municipal Maintenance Company in Cinnaminson, New Jersey submitted the low bid in the amount of \$24,630.00; and

**WHEREAS**, the total cost for the Capital Improvements is expected not to exceed the amount of \$24,630.00; and

NOW, THEREFORE, BE IT RESOLVED by the Southeast Monmouth Municipal Utilities Authority that it hereby authorizes use of the Capital Improvement Fund by the New Jersey Water Supply Authority to proceed with the Capital Improvement Purchases and associated labor for the purchase and installation of a one (1) stage vertical turbine pump and the refurnishing of 24 feet of 14 inch diameter pump head and column pipe at the Manasquan Water Treatment Plant for an amount not to exceed \$24,630.00 inclusive of all labor and to award the contract to Municipal Maintenance Company for that amount.
