RESOLUTION OF THE SOUTHEAST MONMOUTH MUNICIPAL UTILITIES AUTHORITY AUTHORIZING A RENEWAL & REPLACEMENT TRANSFER OF FUNDS INTO THE OPERATING FUND FOR AN AMOUNT NOT TO EXCEED \$10,000.00

WHEREAS, the Southeast Monmouth Municipal Utilities Authority (hereinafter referred to as the "Authority") serves the Township of Wall, the Borough of Brielle, the Borough of Sea Girt, the Borough of Spring Lake and the Borough of Spring Lake Heights and is comprised of member municipalities which receive treated water from the Authority; and

WHEREAS, within the operating budget of the Southeast Monmouth Municipal Utilities Authority funds have been reserved within the Renewal and Replacement Reserve Account for the renewal and replacement of equipment for the Water Treatment Plant located on Hospital Road in Wall, NJ; and

WHEREAS, the New Jersey Water Supply Authority's operations and maintenance staff recently identified the need for a transfer of funds from the renewal and replacement reserve into the 8101 operating fund for grating for the final Absorption Clarify/Filter Unit. The existing grate has been in service for 25 years and will be replaced after new grating is provided at a metal fabrication shop and installed;

WHEREAS, the total cost, inclusive of labor, for the replacement of the grating and replace it with a new grating along with ancillary installation costs at the Manasquan Water Treatment Plant is in the amount of \$10,000.00; and

WHEREAS, Freehold Welding, Inc. submitted the lowest bid to provide the fabricated grating in the amount of \$9,000.00; and

NOW, THEREFORE, BE IT RESOLVED by the Southeast Monmouth Municipal Utilities Authority that it hereby authorizes the New Jersey Water Supply Authority to proceed with the transfer of funds from the renewal and replacement reserve into the operating fund for the replacement of the grating for the final Absorption Clarifier/Filter Unit with a newly fabricated grate by Freehold Welding, Inc. along with ancillary installation costs at the Manasquan Water Treatment Plant for an amount not to exceed \$10,000.00 to cover the cost of this expense.
