### RESOLUTION AUTHORIZING THE SOUTHEAST MONMOUTH MUNICIPAL UTILITIES AUTHORITY TO RENEW ITS COOPERATIVE PRICING SYSTEM AND ITS COOPERATIVE PRICING AGREEMENTS WITH OTHER CONTRACTING UNITS

WHEREAS, the Southeast Monmouth Municipal Utilities Authority, County of Monmouth, State of New Jersey is desirous of renewing its Cooperative Pricing System and and its Cooperative Pricing Agreement with other contracting units; and

WHEREAS, the Southeast Monmouth Municipal Utilities Authority has agreed to serve as the Lead Agency for a Cooperative Pricing System; and

NOW THEREFORE, BE IT RESOLVED, as follows:

#### **COOPERATIVE PRICING SYSTEM IS HEREBY RENEWED**

The Southeast Monmouth Municipal Utilities Authority hereby authorizes the renewal of its Cooperative Pricing System known as SMMUA Cooperative Pricing System with the Southeast Monmouth Municipal Authority serving as the Lead Agency.

### **COOPERATIVE PRICING AGREEMENT**

The Executive Director is hereby authorized to enter into separate Cooperative Pricing Agreements with the participating contracting units and said Agreement shall be deemed a single Agreement.
