RESOLUTION OF THE SOUTHEAST MONMOUTH MUNICIPAL UTILITIES AUTHORITY AUTHORIZING CAPITAL IMPROVEMENT PURCHASES AND ASSOCIATED LABOR FOR IMPROVEMENTS IN AN AMOUNT NOT TO EXCEED \$11,250.00 AND AWARDING A CONTRACT TO MARK WOSZCZAK MECHANICAL

WHEREAS, the Southeast Monmouth Municipal Utilities Authority (hereinafter referred to as the "Authority") serves the Township of Wall, the Borough of Brielle, the Borough of Sea Girt, the Borough of Spring Lake and the Borough of Spring Lake Heights and is comprised of member municipalities which receive treated water from the Authority; and

WHEREAS, within the operating budget of the Southeast Monmouth Municipal Utilities Authority funds have been reserved for Capital Improvement Purchases within the Capital Improvement Fund for the Water Treatment Plant located on Hospital Road in Wall, NJ; and

WHEREAS, the New Jersey Water Supply Authority's in house technical staff recently identified the need to replace ten (10) linear feet of ten (10) inch pipe in the transmission line to replace a temporary clamp that currently covers existing pipe damage. Repaving from curb to curb in the disturbed pavement area is included in the contractors' scope of work. The Authority solicited six (6) bids for the purchase and installation of the equipment; and

WHEREAS, bids were received on November 7, 2018 and Mark Woszczak Mechanical, in Wall, New Jersey submitted the low bid in the amount of \$11,250.00; and

WHEREAS, the total cost for the Capital Improvements is expected not to exceed the amount of \$11,250.00; and

NOW, THEREFORE, BE IT RESOLVED by the Southeast Monmouth Municipal Utilities Authority that it hereby authorizes use of the Capital Improvement Fund by the New Jersey Water Supply Authority to proceed with the Capital Improvement Purchases and all associated labor for the replacement of ten (10) linear feet of ten (10) inch pipe in the transmission line to replace a temporary clamp that currently covers existing pipe damage, as well as repaving from curb to curb in the disturbed pavement area at the Manasquan Water Treatment Plant for an amount not to exceed \$11,250.00 and to award the contract to Mark Woszczak Mechanical, for an amount of \$11,250.00 for completion of this Capital Improvement.
