**RESOLUTION OF THE SOUTHEAST MONMOUTH MUNICIPAL UTILITIES  
AUTHORITY AUTHORIZING A RENEWAL & REPLACEMENT PURCHASE FOR A  
FIBERGLASS STATIC MIXER**

**WHEREAS**, the Southeast Monmouth Municipal Utilities Authority (hereinafter referred to as the “Authority”) serves the Township of Wall, the Borough of Brielle, the Borough of Sea Girt, the Borough of Spring Lake and the Borough of Spring Lake Heights and is comprised of member municipalities which receive treated water from the Authority; and

**WHEREAS**, within the operating budget of the Southeast Monmouth Municipal Utilities Authority funds have been reserved within the Renewal and Replacement Reserve Account for the renewal and replacement of equipment for the Water Treatment Plant located on Hospital Road in Wall, NJ; and

**WHEREAS**, the New Jersey Water Supply Authority’s operations and maintenance staff recently identified the need for the replacement of a fiberglass static mixer on the raw water line, therefore requiring an immediate purchase of a fiberglass static mixer at the Manasquan Water Treatment Plant; and

**WHEREAS**, the total cost for the purchase of a circulating cooling water pump at the Manasquan Water Treatment Plant is in the amount of \$10,222.00; and

**WHEREAS**, two separate quotes were received for the replacement fiberglass static mixers and the lowest quote was from NOV Process & Flow Technologies, Inc., in the amount of \$10,222.00; and

**NOW, THEREFORE, BE IT RESOLVED** by the Southeast Monmouth Municipal Utilities Authority that it hereby authorizes the New Jersey Water Supply Authority to proceed with the purchase of a fiberglass static mixer from the renewal and replacement reserve at the Manasquan Water Treatment Plant for an amount of \$10,222.00 to cover the cost of this replacement equipment expense.
