## RESOLUTION OF THE SOUTHEAST MONMOUTH MUNICIPAL UTILITIES AUTHORITY AUTHORIZING A CONTRACT WITH MIRACLE CHEMICAL COMPANY FOR SODIUM HYPOCHLORITE

WHEREAS, the Southeast Monmouth Municipal Utilities Authority (hereinafter referred to as the "Authority") serves the Township of Wall, the Borough of Brielle, the Borough of Sea Girt, the Borough of Spring Lake and the Borough of Spring Lake Heights and is comprised of member municipalities which receive treated water from the Authority; and

WHEREAS, the Southeast Monmouth Municipal Utilities Authority conducted a bid opening February 14, 2020 and Miracle Chemical Company was the lowest responsible bidder and most responsive bidder for Sodium Hypochlorite; and

WHEREAS, the Southeast Monmouth Municipal Utilities Authority seeks to award the bid to Miracle Chemical Company and authorizes Counsel for the Authority to prepare a contract to be executed by the parties; and



- The Authority Chairman is hereby authorized to execute a contract with Miracle Chemical Company.
