**RESOLUTION OF THE SOUTHEAST MONMOUTH MUNICIPAL UTILITIES  
AUTHORITY AUTHORIZING CAPITAL IMPROVEMENT PURCHASES AND  
ASSOCIATED LABOR FOR IMPROVEMENTS IN AN AMOUNT NOT TO EXCEED  
\$24,100.00 AND AWARDING A CONTRACT TO FRENCH & PARRELLO  
ASSOCIATES**

**WHEREAS**, the Southeast Monmouth Municipal Utilities Authority (hereinafter referred to as the “Authority”) serves the Township of Wall, the Borough of Brielle, the Borough of Sea Girt, the Borough of Spring Lake and the Borough of Spring Lake Heights and is comprised of member municipalities which receive treated water from the Authority; and

**WHEREAS**, within the operating budget of the Southeast Monmouth Municipal Utilities Authority funds have been reserved for Capital Improvement Purchases within the Capital Improvement Fund for the Water Treatment Plant located on Hospital Road in Wall, NJ; and

**WHEREAS**, the New Jersey Water Supply Authority’s in house technical staff has identified the need to replace the 4,000 gallon underground diesel fuel storage tank at the Water Treatment Plant. The improvements under this project will provide fuel for the standby electric power generator and the scope of work includes the removal of the existing underground storage and replacement with a double wall above ground tank; and

**WHEREAS**, bids were solicited and French & Parrello Associates, in Wall, New Jersey, submitted the lowest responsive bid in the amount of **\$24,100.00**; and

**WHEREAS**, the total cost for the Capital Improvements is expected not to exceed the amount of \$24,100.00; and

**NOW, THEREFORE, BE IT RESOLVED** by the Southeast Monmouth Municipal Utilities Authority that it hereby authorizes use of the Capital Improvement Fund by the New Jersey Water Supply Authority to proceed with the Capital Improvement Purchases and all associated labor to purchase and install a new 3,000 gallon double wall above ground diesel fuel tank at the Manasquan Water Treatment Plant for an amount not to exceed \$24,100.00 and to award the contract to French & Parrello Associates for an amount of \$24,100.00 for completion of this Capital Improvement.
