**RESOLUTION OF THE SOUTHEAST MONMOUTH MUNICIPAL UTILITIES  
AUTHORITY AUTHORIZING A CAPITAL IMPROVEMENT PURCHASE OF A  
ROUTER AND MANAGED SWITCH FROM GHA, TECHNOLOGIES.**

**WHEREAS**, the Southeast Monmouth Municipal Utilities Authority (hereinafter referred to as the “Authority”) serves the Township of Wall, the Borough of Brielle, the Borough of Sea Girt, the Borough of Spring Lake and the Borough of Spring Lake Heights and is comprised of member municipalities which receive treated water from the Authority; and

**WHEREAS**, within the operating budget of the Southeast Monmouth Municipal Utilities Authority funds have been reserved for the Capital Improvement Purchases within the Capital Improvement Fund for the Water Treatment Plant located on Hospital Road in Wall, NJ; and

**WHEREAS**, the New Jersey Water Supply Authority’s operations and maintenance staff recently identified the need for an immediate purchase of a router switch which will allow communications between the ozone computer systems and the water treatment interface and data storage computers at the Manasquan Water Treatment Plant; and

**WHEREAS**, the total cost for the purchase of the router and managed switch, at the Manasquan Water Treatment Plant is in the amount of \$6,186.00; and

**NOW, THEREFORE, BE IT RESOLVED** by the Southeast Monmouth Municipal Utilities Authority that it hereby authorizes the New Jersey Water Supply Authority to proceed with the use of funds from the renewal and replacement reserve for the purchase of a

router and managed switch at the Manasquan Water Treatment Plant for an amount of \$6,186.00 to cover the cost of this expense.
