# SOUTHEAST MONMOUTH MUNICIPAL UTILITIES AUTHORITY RESOLUTION NO. 2022-05

### RESOLUTION OF THE SOUTHEAST MONMOUTH MUNICIPAL UTILITIES AUTHORITY AUTHORIZING RENEWAL AND REPLACEMENT PURCHASE AND ASSOCIATED LABOR FOR IMPROVEMENTS IN AN AMOUNT NOT TO EXCEED \$5,100.00 FOR THREE (3) SECTIONS OF PIPING FROM MUNICIPAL MAINTAINANCE INC.

WHEREAS, the Southeast Monmouth Municipal Utilities Authority (hereinafter referred to as the "Authority") serves the Township of Wall, the Borough of Brielle, the Borough of Sea Girt, the Borough of Spring Lake and the Borough of Spring Lake Heights and is comprised of member municipalities which receive treated water from the Authority; and

WHEREAS, within the operating budget of the Southeast Monmouth Municipal Utilities Authority funds have been reserved for Renewal and Replacement Purchases within the Renewal and Replacement Reserve Account, for the Water Treatment Plant located on Hospital Road in Wall, NJ; and

**WHEREAS,** the New Jersey Water Supply Authority's Operations and Maintenance staff has identified the need to replace three (3) sections of piping at the Water Treatment Plant. The improvements under this project will clean clarifiers of accumulated flow during a clarifier backwash; and **WHEREAS,** Gasho, Inc., provided the lowest prices for the purchase of the three (3) sections of piping for the account at \$5,100.00; and

**WHEREAS,** the total cost for the renewal and replacement purchase is expected not to exceed the amount of \$5,100.00; and

**NOW, THEREFORE, BE IT RESOLVED** by the Southeast Monmouth Municipal Utilities Authority that it hereby authorizes use of the Renewal and Replacement Reserve Account by the New Jersey Water Supply Authority to proceed with the Renewal and Replacement Purchases and all associated labor to purchase and install the three (3) sections of piping at the Manasquan Water Treatment Plant for an amount not to exceed \$5,100.00
