**RESOLUTION OF THE SOUTHEAST MONMOUTH MUNICIPAL UTILITIES  
AUTHORITY AUTHORIZING RENEWAL AND REPLACEMENT PURCHASE AND  
ASSOCIATED LABOR FOR IMPROVEMENTS IN AN AMOUNT NOT TO EXCEED  
\$5,890.59 FOR A WIRELESS COMMUNICATION SYSTEM FROM MOUSER  
ELECTRONICS.**

**WHEREAS**, the Southeast Monmouth Municipal Utilities Authority (hereinafter referred to as the “Authority”) serves the Township of Wall, the Borough of Brielle, the Borough of Sea Girt, the Borough of Spring Lake and the Borough of Spring Lake Heights and is comprised of member municipalities which receive treated water from the Authority; and

**WHEREAS**, within the operating budget of the Southeast Monmouth Municipal Utilities Authority funds have been reserved for Renewal and Replacement Purchases within the Renewal and Replacement Reserve Account, for the Water Treatment Plant located on Hospital Road in Wall, New Jersey; and

**WHEREAS**, the New Jersey Water Supply Authority’s Operations and Maintenance staff has identified the need to replace a Wireless Communication System at the Water Treatment Plant. The improvements under this project will monitor the water level in the recycle water pump station; and

**WHEREAS**, Mouser Electronics, provided the lowest price for the purchase of the Wireless Communication System in the amount of \$5,890.59; and

**WHEREAS**, the total cost is not expected to exceed the amount of \$5,890.59; and

**NOW, THEREFORE, BE IT RESOLVED** by the Southeast Monmouth Municipal Utilities Authority that it hereby authorizes use of the Renewal and Replacement Account by the New Jersey Water Supply Authority to proceed with the purchase and all associated labor to install a Wireless Communications System in order to monitor the water level in the recycle water pump station at the Manasquan Water Treatment Plant, for an amount not to exceed \$5,890.59.
