**RESOLUTION OF THE SOUTHEAST MONMOUTH MUNICIPAL UTILITIES  
AUTHORITY AUTHORIZING A CONTRACT WITH FERGUSON WATERWORKS,  
FOR HYDRANT SUPPLIES**

**WHEREAS**, the Southeast Monmouth Municipal Utilities Authority (hereinafter referred to as the “Authority”) serves the Township of Wall, the Borough of Brielle, the Borough of Sea Girt, the Borough of Spring Lake and the Borough of Spring Lake Heights and is comprised of member municipalities which receive treated water from the Authority; and

**WHEREAS**, the Southeast Monmouth Municipal Utilities Authority conducted a bid opening April 28, 2022 and Ferguson Waterworks, was the lowest responsible bidder and most responsive bidder for Hydrant Supplies; and

**WHEREAS**, the Southeast Monmouth Municipal Utilities Authority seeks to award the bid to Ferguson Waterworks, and authorizes Counsel for the Authority to prepare a contract to be executed by the parties; and

**WHEREAS**, the bid process and the awarding of the contract is pursuant to the cooperative purchasing guidelines of the Southeast Monmouth Municipal Utilities Authority; and

**WHEREAS**, the Financial officer of the Authority has determined that sufficient funds are available for the contract; and

**WHEREAS**, Ferguson Waterworks has completed and submitted a Business Entity Disclosure Statement which certifies and that Ferguson Waterworks, has not made any reportable contributions to a political candidate committee which would be prohibited by law.

**NOW, THEREFORE, BE IT RESOLVED** by the Southeast Monmouth Municipal Utilities Authority as follows:

1. The Authority Chairman is hereby authorized to execute a contract with Ferguson Waterworks.
2. A copy of this resolution together with the Business Disclosure Entity Certification submitted by Ferguson Waterworks, shall be placed on file in the Authority Offices.
3. The Authority Secretary shall arrange for publication of Notice of the foregoing action of the Authority in the authority's official newspaper.
