RESOLUTION OF THE SOUTHEAST MONMOUTH MUNICIPAL UTILITIES AUTHORITY AUTHORIZING RENEWAL AND REPLACEMENT PURCHASE AND ASSOCIATED LABOR FOR IMPROVEMENTS IN AN AMOUNT NOT TO EXCEED \$12,348.47 FOR A PLANT PROCESS CONTROL ROUTER AND SIX ROUTERS FOR THE INTERCONNECT VAULTS FROM PHOENIX CONTACT SYSTEM

WHEREAS, the Southeast Monmouth Municipal Utilities Authority (hereinafter referred to as the "Authority") serves the Township of Wall, the Borough of Brielle, the Borough of Sea Girt, the Borough of Spring Lake and the Borough of Spring Lake Heights and is comprised of member municipalities which receive treated water from the Authority; and

WHEREAS, within the operating budget of the Southeast Monmouth Municipal Utilities Authority funds have been reserved for Renewal and Replacement Purchases within the Renewal and Replacement Reserve Account, for the Water Treatment Plant located on Hospital Road in Wall, New Jersey; and

WHEREAS, the New Jersey Water Supply Authority's Operations and Maintenance staff has identified the need to purchase a plant process control router and six routers for the interconnect vaults at the water treatment plant. The routers provide cyber security in accordance with state and federal mandates; and

WHEREAS, Phoenix Contact System, provided the lowest responsive bid for the purchase and installation for the required routers in the amount of \$12,348.47; and

WHEREAS, the total cost is not expected to exceed the amount of \$12,348.47; and

NOW, THEREFORE, BE IT RESOLVED by the Southeast Monmouth Municipal Utilities Authority that it hereby authorizes use of the Renewal and Replacement Account by the New Jersey Water Supply Authority to proceed with the purchase and all associated labor to install required routers to provide cyber security in accordance with state and federal mandates at the Manasquan Water Treatment Plant, for an amount not to exceed \$12,348.47.
