RESOLUTION OF THE SOUTHEAST MONMOUTH MUNICIPAL UTILITIES AUTHORITY AUTHORIZING RENEWAL AND REPLACEMENT PURCHASE AND ASSOCIATED LABOR FOR IMPROVEMENTS IN AN AMOUNT NOT TO EXCEED \$6,314.00 FOR A WATER COOLING UNIT FOR OZONE GENERATOR #2 FROM MILLPOND SALES, LLC

WHEREAS, the Southeast Monmouth Municipal Utilities Authority (hereinafter referred to as the "Authority") serves the Township of Wall, the Borough of Brielle, the Borough of Sea Girt, the Borough of Spring Lake and the Borough of Spring Lake Heights and is comprised of member municipalities which receive treated water from the Authority; and

WHEREAS, within the operating budget of the Southeast Monmouth Municipal Utilities Authority funds have been reserved for Renewal and Replacement Purchases within the Renewal and Replacement Reserve Account, for the Water Treatment Plant located on Hospital Road in Wall, New Jersey; and

WHEREAS, the New Jersey Water Supply Authority's Operations and Maintenance staff has identified the need to purchase a water cooling unit for Ozone Generator #2 at the Water Treatment Plant. It will replace an existing commercial water source heat pump used to cool one of the two ozone generators; and

WHEREAS, Millpond Sales, LLC, provided the lowest price for the purchase of the water cooling unit in the amount of \$6,314.00; and

WHEREAS, the total cost is not expected to exceed the amount of \$6,314.00; and

NOW, THEREFORE, BE IT RESOLVED by the Southeast Monmouth Municipal Utilities Authority that it hereby authorizes use of the Renewal and Replacement Account by
