In old business, Stephanie DeCotiis provided an update for the Northwest Wall Tank progress. The tank is full; it was filled to do a leak test to then back-fill the area around the tank. Pump station construction is progressing; changed construction inspector. Significant amount of electrical work that needs to happen at primary tank site and electrical station on Route 34. They are working with the constructor to figure out the new extension of time. Stephanie further stated there is a change order prepared to do the temporary electric; it will be needed to power the site.

Stephanie further stated, regarding pilot study and PFAS at the plant, they have been progressing based on authorization from SMMUA and ordered necessary hardware (small cannisters to test GAC in series with resin); test small versus large scale.

In new business, Paul McKeon stated October was stable at the treatment plant. There was some algae clogging the filter at the reservoir and they treated the reservoir, which was successful. Paul further stated they are going to rehab the four filtered water pumps; they went out to bid for the first for a new pump. Paul requested a verbal vote to proceed and memorialize via formal resolution at the next meeting.

Jeff Bertrand called for a motion to approve the request and memorialize at the next meeting.
