The Southeast Monmouth Municipal Utilities Authority members met on December 4, 2025. In further old business, Pat Cole stated they are completing the PFAS pilot at the plant and analyzing the information; the report is complete and will be submitted to the board in the next few days. They are looking to work with NJWSA to review the report and move forward to solicit services to expand.
